All vendors are required to give a written document of gross income collected during the event and 5% will be collected from that total

and given to the Ocala National Forest Treasury Department.

This 5% must be collected before you leave the venue.

Vendors may arrive by 10 am Thursday morning.

The vending space must be ready by 10 am Friday morning.

Vendors may camp Sunday evening, but must be ready to vacate the venue by 9 AM Monday morning.

Absolutely No Drug Paraphernalia will be sold. Paralounge withholds the right to deny any vendor.
